## **2020 Vendor Application**

Sunday, June 14<sup>th</sup> - Sunday, October 4<sup>th</sup>, 10:00 a.m. - 2:00 p.m. The intersection of First St. and Main St., North Andover, MA Application deadline: March 1, 2020

Thank you for your interest in becoming a Vendor at the 2020 North Andover Farmers Market (NAFM)! Below you will find all the information about what we offer to you as a Vendor and how we operate. Please read this, as well as the NAFM 2020 Rules & Regulations, before submitting your application. Feel free to contact us with any questions at info@northandoverfarmersmarket.org.

- The NAFM provides tents for each vendor booth. Vendors can reserve a 10' x 10' booth or 10' x 20' booth (vendors must provide their own chairs, tables and waste receptacle for booth-generated waste.)
- The NAFM provides public waste receptacles, as well as state and local certified hand washing stations.
- The NAFM provides electricity to your booth (for an additional fee).
- The NAFM features locally grown, produced or crafted items such as would be found at a traditional Farmers Market. Preference in the approval process will be given to applicants who offer such products.
- The NAFM reserves the right to reject any applicant whose service is inconsistent with the mission of the NAFM. Each Vendor will only be reviewed upon receipt of a completed application and payment.
   Applicants will be notified by March 30, 2020. Fees of accepted vendors are non-refundable.

Fees: You can choose to participate as a seasonal vendor or as a week-to-week vendor.

**Seasonal rate (17 weeks):** \$275 for a 10' x 10' booth or \$375 for a 10' x 20' booth. *Full-season vendors who participated in the 2019 market receive a \$25 discount.* 

Week-to-week rate: \$35 per week for a 10x10' booth or \$45 per week for a 10x20' booth.

**Electricity:** Electricity will be available for a one-time fee of \$25, regardless of whether you sign up as a seasonal or week-to-week vendor. The NAFM provides a power cord that reaches to your booth location. Additional power cords and power strips are the responsibility of the Vendor.

## **Payment Information**

All applications and fees must be submitted by March 1, 2020. All required permits and proof of insurance must be submitted by April 30, 2020.
